Board-Assessed/Legislative Allowed Fees		
Fee	Amount	Description
Tuition	\$5,669.00	Approved fees implemented by governing board of the University. The fees are collected to support the operations of the University. The fees are used in the general operating budget.
Out - of - State	\$6,300.00 \$6,800.00	Authorizes Universities to determine tuition and fees applicable to nonresident students. The fees are collected to support the operations of the University. First Year students are charged \$6,800. Second- and third-year students are charged \$6,300.
Academic Excellence	\$120.00	The proceeds of this fee are used to enhance instructional programs. It cannot exceed \$10.00 per credit hour or \$120.00 per academic session and is waived in cases of financial hardship.
Operational Fee	\$114.00	This fee is used for the enhancement of instructional programs. It cannot exceed 4.0% of an institution's total tuition and fees for the fall 2004 semester. It is waived for cases of financial hardship.
Academic Enhancement	\$25.00	The fee is designed to support academic programs and may be used at the University's discretion (but may not be used for faculty/staff salaries or travel). Funds may be used for instructional library books or equipment, student laboratory equipment, student computer laboratory equipment, or any expenses specifically.
Building Use—Act 619	\$10.00	This fee is used to finance bonds issued to construct, acquire, extend, repair, or improve any academic facilities suitable for use as a classroom, laboratory, gymnasium, library, student infirmary and related facilities. It currently serves as a de facto maintenance fee.
Building Use—Act 426	\$38.00	The proceeds of this fee are used to construct, acquire, repair, maintain, operate, or improve facilities and physical infrastructure. It cannot exceed \$48.00 per semester and must be waivable in cases of financial hardship.
Technology Fee	\$60.00	The proceeds of this fee are used to implement, replace, improve, and expand technologies to benefit student life and learning in accordance with a written plan. It is (dis)established by a student vote. It cannot exceed \$5.00 per credit hour or \$100.00 per semester, and no one is exempted from payment.

Energy Surcharge	\$48.00	This fee is charged to student to cover increased costs of utilities. The amount of this surcharge is directly related to these specific costs and will be periodically adjusted up or down to reflect future increases or decreases in these outlays.
University Self-Assessed Fees		
Fee	Amount	Description
Athletic Facilities Improvement	\$25.00	This fee is used to improve academic facilities.
Athletic Facility	\$4.00	This fee is used to support college athletic facilities.
Athletic	\$250.00	This fee covers the cost of all athletic related activities and allows students to attend the events free of charge.
Breakage	\$1.50	\$1.50 per semester for full-time students only. This fee is to cover any damage to classrooms.
Recreation	\$3.00	This fee supports university recreation.
Restricted Facilities	\$10.00	The fees are collected for Athletic activities at the University. The funds are used in the Athletics Budget.
University Support	\$1,462.00	This fee covers the increased operational costs incurred with maintaining equipment and student support services.
Student Success	\$541.00	The fee is designated to improve the bar passage rates by providing assistance with preparations for the bar exam and to institute a common exam.
Exam 4	\$12.00	Electronic exam system used by students to take exams.
Law Library	\$10.00	Law Library Fee is a University Self-Assessed fee imposed on the student body. The fee is used in the general operating budget.
EBook	\$950.00	Fee charged to provide students with access to casebooks, textbooks and other legal education using electronic books.
Live Text	\$98.00	This is a one-time fee charged to incoming students which gives them access to the University's assessment system.

iPad	\$800.00	This is a one-time fee charged to incoming students for the purchase of an iPad to use during their matriculation through school.
Modern Law Certification	\$200	Fee charged to provide students practice-oriented professional training in business processes, project management, leadership, communication, political acuity and tech skills.
Bar Prep	\$500	Fee charged to assist students to prepare for the Bar Exam.
International	\$30.00	This fee is charged to International Students

Fee	Amount	Description
Student Bar Association	30.00	This fee supports the Student Bar Association. An organization that specializes in student advocacy, initiatives and participation.
Student Loan Association	\$1.00	Student Loan Association Fee is a Student Assessed fee imposed on the student body. The fee is used for small short-term emergency loans to students.
Social Activities	\$3.00	This fee supports initiatives that enhance student life.
SBA Grant Fund	\$15.00	This fee supports student travel for conferences, competitions and development.
Public Defender Newspaper	\$4.50	Student Publication (Yearbook) Fee is a Student Assessed fee imposed on the student body. The fee is used to publish the Public Defender Newspaper.
Health	\$150.00	All students charged the health fee are eligible to see providers in the University clinic and receive all formulary medications.
Intramural Complex	\$54.00	This fee supports the Horace W. Moody Intramural Sports Complex, providing both organized and informal sports programs.
Men and Women Federation	\$2.00	The Men Federation Fee was created for the specific purpose of supporting the Men Federation and The Women Federation Student Fee was created for the specific purpose of supporting the Women's Federation.

Student Facilities Extension	\$5.00	The Facilities Extension Fee was created for the specific purpose of supporting the operation, staffing and maintenance of the Student Union.
Student Identification	\$5.00	This fee supports mandatory student identification cards.
Student Union	\$45.00	The Student Union Fee was created for the specific purpose of supporting the operation, staffing and maintenance of the Student Union
