**Judge Zoey Waguespack Will Be Featured Speaker for
SULC 2012 Hooding Ceremony, January 13**

Judge Zorraine “Zoey” Waguespack of the 21st Judicial District Court, Division H, will be the featured speaker for the Southern University Law Center (SULC) Hooding Ceremony, set for 6 p.m., Friday, January 13, 2012, in 129-130 A. A. Lenoir Hall.

Judge Waguespack, a 2009 inductee into the SULC Hall of Fame, graduated first in her SULC class in 1988. She clerked for the First Circuit Court of Appeals, then opened her own private law practice and later became partners with Carolyn Ott. Waguespack was Walker Town Magistrate for ten years and the attorney for the Livingston Activity Center and the Livingston/Denham Springs Mortgage Housing Authority. She has served as district judge since her election in 1998.
