BRIDGING DOCTRINE AND PRACTICE: LEGAL ANALYSIS & WRITING II STUDENTS ENGAGE IN REAL-WORLD ADVOCACY



Southern University Law Center recently welcomed back distinguished alumnus Tony Clayton ('91), District Attorney for the 18th Judicial District Court and Chairman of the Southern University Board of Supervisors, for an engaging visit with students in the Legal Analysis & Writing II course. During his time on campus, Clayton delivered a compelling presentation on oral advocacy and trial strategy, offering practical insight into courtroom practice. His candid perspective, extensive experience, and dynamic delivery left a lasting impression on students.

Building on their classroom learning, Legal Analysis & Writing II students also attended oral arguments at the First Circuit Court of Appeals, where they observed appellate advocacy firsthand. The experience was further enriched by Law Center alumnus and adjunct professor Judge Wilson Fields ('94), who generously met with students to provide a walkthrough of the appellate process and answer questions. His willingness to engage transformed the visit into an interactive and meaningful learning opportunity.

SULC TECHNOLOGY AND ENTREPRENEURSHIP CLINIC STUDENTS WITNESS FEDERAL APPELLATE ADVOCACY IN ACTION



Student attorneys from the Southern University Law Center's Technology and Entrepreneurship Clinic recently gained firsthand insight into federal appellate advocacy during a visit to the United States Court of Appeals for the Fifth Circuit.

Students attended oral arguments in a trademark case and observed experienced litigators present complex legal issues before a three-judge panel. The opportunity provided a rare, real-world look at appellate strategy, courtroom decorum, and the nuanced questioning that shapes federal appellate decisions.

Beyond observing the proceedings, the students had the chance to engage with the attorneys who argued the case, discussing litigation strategy and professional pathways in intellectual property law. Following the hearing, the group had the distinct honor of meeting with Carl E. Stewart, who serves on the Fifth Circuit.

Judge Stewart shared insights about appellate practice and the role of the federal judiciary, offering encouragement and perspective to the aspiring attorneys.

Louisiana Public Broadcasting and Southern University A&M College partnered to host a free Indie Lens Pop-Up screening of *The Inquisitor*, presented in collaboration with ITVS and Independent Lens.

The documentary centers on the life and legacy of Barbara Jordan, a trailblazing Texas congresswoman whose intellect, integrity, and moral clarity left a lasting mark on American politics. From her historic role during the Nixon impeachment proceedings to her leadership in advancing civil rights, Jordan's public voice consistently called for accountability, even as the film also explores the private complexities of her life and intersectional identity.

Following the screening, attendees participated in a thoughtful and engaging panel discussion reflecting on Jordan's enduring impact on American democracy and the continued relevance of her story today.
