## SPECIAL INSTRUCTIONS

1. Third year required courses and third year-only electives end on Friday, April 14, 2017
2. In all courses, students who are graduating must inform their professors of this status by indicating on their examination –“graduating senior.”
3. Final grades for “graduating students” must be submitted to the Department of Records and Registration as soon as possible, but no later than Friday, April 28, 2017.
4. Classes will end on Thursday, April 20, 2017 for students not graduating.
5. Final grades for non-graduating students are due in the Department of Records and Registration on or before Friday, May 19, 2017.
6. All grades will be given only in strict compliance with Law Center regulations.
7. Students must use their Personal Identification Numbers (PIN) to identify their examination answers and should be reminded that PINs will be distributed via email.
8. Please refer to the examination conflict policy for examination conflict. Conflicts examinations will be given on May 8, 2017. The absolute last date to request to take an examination on the conflict day is March 30, 2017.
