OVER 30 RECEIVE JURIS DOCTORATE DEGREES DURING FALL 2022 COMMENCEMENT CEREMONY



On January 21, over 30 graduates received their Juris doctorate degree during the Fall 2022 Commencement Ceremony for the Southern University Law Center. The prestigious ceremony was held at the F.G. Clark Activity Center on the campus of Southern University Baton Rouge. Honorable Judge John Guidry, chief judge of the Louisiana First Circuit Court of Appeal, served as the commencement speaker.

Chancellor John Pierre opened up the program by welcoming platform guests, family, friends, and guests. He went on to give encouraging words to the graduates. Pierre paid homage to Charles Hatfield, a Baton Rouge native that filed the historic lawsuit which led to the opening of the Southern University Law School.

Over the course of his legal career, Guidry was a former commissioner of the Greater Baton Rouge Port Commission and the Greater Baton Rouge Metropolitan Airport Commission. While maintaining a general private law practice, he formerly served as the assistant clerk of the Louisiana House of Representatives and an Assistant Parish Attorney for the City of Baton Rouge and East Baton Rouge Parish. In 1991, he was elected to the Louisiana House of Representatives and the State Senate in 1993. Guidry was first elected as a judge of the First Circuit Court of Appeal in October 1997. Guidry poured positive affirmations into the graduates. He reminded them that they are the legacy of Charles Hatfield and the institution's first five graduates.

Myron Lawson, Southern University System Board of Supervisors chairman, and Dennis J. Shields, president of the Southern University System and chancellor of the Southern University and A&M College, and Naudia Foster, Student Bar Association president, shared closing remarks.

The ceremony was live-streamed and recorded on the Law Center's YouTube channel.

Over 70 Law Center students participated in the inaugural series of the AbbVie Legal Academies at Southern University Law Center. Designed as an intensive intercession experience, each Academy offered students focused task-oriented training, through actual practice experience.

During the three-day series, students practiced drafting patent claims, worked on simulated M&A deals, and prepared for mock trials before state and federal judges

with help from lawyers from AbbVie's legal department, and senior attorneys from Baker Donelson, DLA Piper, and Kirkland & Ellis.

The intellectual property legal academy gave students at various stages of their legal education, an overview of patent prosecution and litigation. The Deals Academy provided 24 students with intensive M&A and licensing training, including a mock life science M&A term sheet negotiation simulation.
