SOUTHERN UNIVERSITY LAW CENTER CHAMPIONS LEGAL INNOVATION AT THE ANNUAL AFROSPORT SUMMIT IN GHANA

The Southern University Law Center has been a proud sponsor of the AfroSport Summit in Accra, Ghana for the past two years. To enhance the institution's global presence, representatives from the Office of Innovation and Strategic Partnerships and Initiatives journey to West Africa each year to share valuable insights into legal trends and the emerging esports industry.

The AfroSport Summit, which took place July 17-18, brought together influential sports stakeholders from Africa and beyond, creating a unique platform for learning, idea exchange, and networking at the intersection of science and business. Attendees participated in sessions covering topics such as fan engagement, governance, team performance, and media strategies.

This year, Marla Dickerson, Vice Chancellor of Innovation and Strategic Partnerships and Initiatives, and Chris Turner,

Director of the Mixed Reality Virtual Innovation Gaming and Esports Institute, led a discussion titled "Driving Legal Excellence in Gaming, Esports, Music, and Entertainment." They were accompanied by Kwesi Hayford, President of the Ghana Esports Association, and Danny Martin, Co-founder and CEO of Esposure, to explore various subjects including contracts, branding, and gaming trends.

Furthermore, the Institute organized the SULC Cross Over II Esports Tournament, featuring competitions in NBA 2K and FC24. With a substantial prize pool, the tournament attracted over 50 spectators.

Throughout the two-day conference, SULC representatives actively engaged with attendees, sharing information about the Southern University System and distributing various keepsakes.
